POLICY TRENDS



- Federal activity relating to foodservice packaging under their plastics initiatives has slowed
- Continued provincial extended producer responsibility program introduction, evolution, expansion and harmonization efforts
- British Columbia remains most active at the provincial level


CANADA

- On April 22, 2024, the Government of Canada published a Section 46 <u>Notice with respect to</u> reporting of plastic resins and certain plastic products for the Federal Plastics Registry for 2024, 2025 and 2026
- Canada hosted the Fourth Intergovernmental
 Negotiating Committee (INC-4), April 23 to 29, 2024

TOP POLICY TRENDS




- Some federal activity in 2024

- Short sessions have proven challenging for the passage of EPR proposals
- Legislative and regulatory definitions of "plastics" continue to go beyond plastics-only items

FEDERAL ACTIVITY

- Senate Environment and Public Works Committee

 Examining Extended Producer Responsibility for Consumer Packaging
- The <u>Recycling Infrastructure and Accessibility Act</u> and <u>Recycling and Composting Accountability Act</u> out of the Senate
- Discussion Draft circulating regarding "national labeling standards for recyclability, compostability, and reusability, and for other purposes"


2024 STATE LEGISLATIVE LANDSCAPE

225 proposed pieces of legislation relating to FSP in 30 states.



CALIFORNIA REPUBLIC

SB 1167 – Single-use drinking vessels

SB 1231 – Plastic Pollution Prevention and Packaging Producer Responsibility Act: environmental advertising

SB 1053 – Reusable grocery bags, and plastic film prohibition

AB 2761 – Plastic packaging: Reducing Toxics in Packaging Act (PFAS, PVC, PVDC)
